 - a. Kurt Kiefer, DPI, invited Shelley to work with his team to develop the questions to meet the requirements of ESSA.
 - b. Mike Thompson thanked Shelley and the team for making this happen. As we learn more from the field and users, DPI will modify the questions to ensure they are user friendly.
 - c. Gregg C. also added comments that the DPI will be monitoring the incoming data. This information will help all to be more aware and better serve our students.
- 8. Information on joint activity between the Wisconsin Department of Public Instruction and the Wisconsin Department of Military Affairs and the Army National Guard.
 - a. AUG 10-12, St. John's Military Academy, Delafield, WI
 - i. Shelley summarized the very successful activities of the weekend. The goal was to develop teamwork, leadership, and support networking while sharing the types of educational programs the Army National Guard has available and can bring to classrooms. Additionally, the Soldiers shared opportunities they can offer graduating seniors. Approximately 60 folks including educators and military members were involved. The WI DMA and the WI Army National Guard fully funded the event. Educators commented throughout the weekend on how applicable the activities and information was to their classrooms. Mark Mueller, DPI and Scott Lafler, Education Liaison to the WI DMA were instrumental to this successful event. Lt Col Dean Nemecek, Army National Guard was the Officer responsible for the funding and personnel involved. We are already planning for next year and will increase the number of people involved.
