4. **Review** WA progress around meeting our state's and national Compact requirements in support of our military/uniformed connected children in WA public schools.
5. **Monitor**, update and discuss our State Council membership and governance procedures.
6. **Discuss**, provide answers, and receive comments and questions from all meeting attendees about the Compact or any other topics included in the meeting agenda.
