Accomplishments

- State of CA Yearly dues paid in full by the CA Department of Education SSPI Tony Thurmond
- Council appointed a new Commissioner in Summer 2020
- Council received a new DoD representative in Fall 2020 (Cecilia Yacuta, USN)
- Council received a new CA Department of Education Representative (Stephanie Papas, Senior Education Administrator)

- The State Council supported Month of the Military Child activities in the state through individual council member participation in social media awareness activities.
- Council increased its access and accountability to the public by updating its website and providing more ways that the public can participate in council meetings
- CA Department of Education increased its support to the MIC3 and accountability to the public by updating its Military Family support webpage and providing digital resources to schools, families, and the public.
- Council increased its reporting and awareness with the CA State Board of Education (SBE) by reporting out via is SBE Member at each SBE meeting. This is significant as it increased awareness throughout the state during these high visibility meetings.
- CA Department of Education and the CA State Superintendent of Public Education Tony Thurmond approved and developed the Purple Star School Recognition Program in Summer 2021. The first schools and districts to be recognized will be announced in 2022.
- MIC3 served as an informal conduit of information between the CA Military bases and Defense Sate Liaison Office and the CA Department of Education.
