- Commissioner Buehn welcomed newly appointed State Senator David Burgess to the MIC3 Council.
- Commissioner Buehn attended the annual business meeting of the interstate compact in Baton Rouge, LA. He is still on the finance committee; however, no longer serves as treasurer.
- Dr. Aune provided a brief review of the Education Family Liaison nominees for the Council. There were three nominees submitted for consideration. The Council may submit up to five nominees to Governor DeSantis' office for consideration of the position. Each of the nominees completed the same consistent fields including experience with the U.S. Armed forces, K-12 education and their motivation or interest for joining or wanting to serve in this role. The three nominees are:
 - <u>Andrew Wetherill</u> Senior Director of Student Support Services, Bureau of Exceptional Education and Student Services (BEESS), Florida Department of Education (FDOE), in collaboration with University of South Florida.
 - <u>Michael Newsome</u> Former active duty Marine and current Marine Corps Reservist platoon commander. Mr. Newsome currently works as a Program Specialist within BEESS serving as an investigator for alleged violations against school districts with respect to students with disabilities
 - <u>Lisa Hill</u> Military spouse for 32 years with experience in the U.S. Army, U.S. Air Force (USAF) and performing joint assignments. During most of those assignments, she mentored military spouses and helped them navigate through the various challenges that military families face. Mrs. Hill also shared her experiences in K-12 education as well as her interest in serving in this role.
 - The three nominees have been confirmed to move forward with pertinent information as well as a cover letter from Commissioner Buehn for the Governor.

Commissioner Buehn opened the floor for comments regarding the nominees. Elaine
LaJeunessee shared how she wanted to re-emphasize that each nomine should have experiences
in education and working with military families who are transferring from overseas to stateside,
and from district to district.

- Mr. Hoeft shared concerns about the USAF Support of Military Families Report from 2018 and how this process is being done. He stated how Florida is deeply concerned that the model established by the USAF provides a misleading picture of the state of public education in Florida. The result of this report potentially harms military families and Florida's reputation as one of the top military friendly states in the nation. The Support of Military Families Report ranks all 157 USAF installations in the nation and will likely be considered as a key factor by the Armed Services in their future decision making. This was the finding of the report.

- It is important that FDOE and MIC3 members continue to engage with the USAF and the Department of Defense on this matter to work toward a solution. It appears that the Department of the Navy and the Department of the Army are going to have to produce reports similar to the USAF's report by the end of 2023. It is essential that the two other service branches do not use the same criteria currently being used by USAF when they produce their reports. However, it is also essential that all the service branches use the same criteria so that there is data and report uniformity across the branches. This has been an ongoing issue in dialogue since 2020. Therefore, we need to make sure we arrive at a fair and informed solution.
- Steve Horton, Okaloosa County, shared how they have been having the same concern for number of years. They have engaged with their military officers and the military officers association with General Hendrix, who wrote a letter on behalf of the Secretary of the USAF on this very topic and did receive a response. They are still reaching out to provide some clarity from the local school district.
- Lacey Allen shared, on behalf of the USAF, that school liaisons are also sharing their concerns with their leadership regarding some of the discrepancies within the report.

10:30-10:35 Purple Star Schools Designation Update Andria Cole, Chief, Bureau of Family and Community Outreach

- Andria Cole reported that 122 schools earned the Purple Star School of Distinction designation during this inaugural year. This designation is effective for three years, so it will expire at the conclusion of the 2024-25 school year. Letters and certificates were mailed to the schools. Ms. Cole asked that meeting participants let her know if the certificates were received, or if they were any questions. Please contact Ms. Cole at Andria.Cole@fldoe.org. In addition, you will receive future communication concerning the availability of the Purple Star School of Distinction logos as well as guidelines for the use of those logos from FDOE.
- Following the meeting, Ms. Cole will email members to ensure they receive the logo so they can be celebrated by the members of the council, schools, families and community members.
- The application process will be open at the beginning of August and will close at the end of September for the 2023-2024 school year. Ms. Cole will post information on the Bureau of Family and Community Outreach's website, which can be found on the FDOE website under Bureau of Family and Community at Outreach under Family and Engagement. They will also send out notification once the website has been updated with the new application.

- Cherise Imai, following up from Commissioner Buehn, stated that the National Commission held their annual business meeting (ABM) this past October. It was the first in-person meeting since 2019. The budget was passed. Some of the significant things that were launched is a training or compact 101 in Spanish. This is certainly an accomplishment for the training committee. This is being promoted out to members as well as our stakeholders to encourage and promote the Spanish video as well. The Committee is currently working on translating their guides and brochures into Spanish.
- Some of the key decision making items that occurred at the ABM are several rules, changes and updates money, particularly on extracurricular activities, which specifies that schools will promote or make available opportunities to try out for sports or activities to families in a public venue. Meaning that if it is posted on a bulletin board, sent home to families or posted in a newsletter, it is a way for incoming families/students to be able to obtain that information so they can try out for extracurricular activities. Ms. Imai will send the link to the mirror so that she may publish it or send it out to the members of this committee. You can view the digital version or request hard copies free of charge. Just email the National Office and they will send you the most updated copies.
- Another item that was significant at the ABM was issue on the National Guard and Reserve. The Commission determined they would not open up the Compact and change all the statutes and all the 50 states in the District of Columbia. They decided to allow states to pass separate language externally from the Compact, which is easier and faster because it's effective upon passage. The Commission has created a tool kit and it will go before the Executive Committee next week for approval. Once approved, the toolkit will be disseminated to members. Several states have already indicated they will be introducing the language in the upcoming legislative session and they will be using that as a guidance for that initiative.
- The National Office is working on their third strategic plan. They are working on a general, overall learning management system that will provide on-demand training online to members and stakeholders. It will be free of charge. Hopefully, they will finish this year and launch it at the next ABM. They are also working on developing our Compact 101 Training video in American Sign Language. They have secured a vendor. They just have to work with the vendor to get the video tapes and sync them with our speaking version of the Compact 101 Training.
- Free monthly trainings offered (Compact 101 Training). Trainings are offered virtually the third and fourth week of the month. Training participants will receive a certificate of completion, which can be used for professional development for education licensing or for the Purple Star Award.
- Onboarding for new commissioners working on a new mentoring program. New commissioners are being mentored by seasoned commissioners.

- Dr. Aune shared that we are committed to continue Chancellor Oliva's legacy at FDOE in these efforts.
