**Agenda:**

- I. Welcome/Call to Order
  1. MO Compact Commissioner Brian Henry called the meeting to order at 9:03am CT.
  
- II. Approve Minutes from October 2020
  1. Dr. Jerrod Wheeler motioned to approve the minutes, seconded by Dr. Margie Vandeven. Motion passed.
  
- III. Discussion
  1. Review of Month of the Military Child

      - I. Commissioner Henry stated this year was the best one to date, there was great turnout and support from state council members for the event at Waynesville. He noted there was an increase in participation of districts and schools across the state.
      - II. Governor Parsons was invested and produced a video declaring April as the MOTMC and encouraged Missourians to wear Purple to show support for military children, and the State Capitol was lit in Purple.
      - III. The hope was this support would continue in the future, and Commissioner Henry suggested next year perhaps they could get kids and others that are military connected to the Capitol.
  2. Reminder of the Successful Transitions Video Program

      - I. Commissioner Henry shared the program information and encouraged members to disseminate to their stakeholders. The purpose of the program is to collect and share successful cases in which the compact helped military kids.

    - II. Mr. Joe Driskoll noted the data for National Guard and Reserve may not be accurate. He said a number of Missouri's reserve members reside outside of the state and travel to in for weekend drills.

    - I. Commissioner Henry encouraged members to seek and identify opportunities to share, promote, and educate about the Compact.
    - II. Ms. Imai noted the Commission offers no-cost training for states, districts, schools, and organizations on request.
