 6. Update from Shelley Joan Weiss
 - a. Welcome to Col Stephen Messenger, Department of Defense/Military Representative, Senator Rachel Cabral - Guevera, Representative Shae Sortwell, Legislative Representatives, and Connie Lewis, Legislative Staff Member. We are pleased to have them join us for their first meeting.

- b. Thank you to Senator Patrick Testin and Lt Col John Wheeler for their service to the Military Children of Wisconsin and to our Council.
 - c. Participated in [Compliance Committee](#) Meetings.
 - i. Wisconsin is current on all compliance issues.
 - ii. Wisconsin is current on fees payments
 - d. Commissioner Weiss is continuing her attempts to pursue connections with the various branches of the military and the other agencies ([Commissioned Corps of the Public Health Services](#), [National Oceanic and Atmospheric Administration](#)) whose children we are supposed to support.
 - i. Trying to connect with the different branches we are responsible for supporting.
 - ii. Wisconsin supports all children whose parents are members of the active branches of the military and the children of the Guard and Reserve.
 - iii. Department of Defense Education Activities has provided some connections.
 - iv. Let Shelley know if you can connect her with individuals from the various branches.
 - v. Rebecca Boehlke, Military One Source has connections. She and Shelley will discuss further.
7. April, Month of the Military Child
- a. JD Engelhardt, National Guard Child and Youth Program - announcement
 - i. Work with Natl Guard Child Need Program
 - ii. Educational goodie packets for National Guard children with the Theme "I am strong."
 - 1. Over 400 people signed up for packets including families from Wisconsin and surrounding states.
 - 2. "Sold out" of these packets. JD will increase the request for more packets for 2024 based on their popularity.
 - iii. Virtual Day Camp on Apr. 11 (grades 1-5), Apr. 18 (grades 6th -12th)
 - iv. The Teen Summit is April 14-16, 2023.
 - 1. Capitol Tour scheduled for Apr 15.
 - 2. Planning for a legislative representative to talk to the children.
 - a. Note that Shelley has reached out to our current legislative representatives, Senator Testin (past Council member), and Senator Dianne Hesselbein (military family member, parent of military children)

 - 3. 125 military children (general).
 - 4. All tickets are sold out.
 - 5. Wait list.
 - 6. JD is working to expand opportunities for this day camp in the future.
 - vi. Quarterly camps and mental health activities. Children of service members besides Natl Guard are included.
 - vii. Will attempt to increase opportunities available next year.
 - viii. Has built an email list from participants.
 - 1. Advertise on Facebook and Instagram.
 - 2. Emails participants directly and works to limit emails.
 - 3. People are responding to email list and events filling up within a week or so.
