ITEM 1 – DEPARTMENT WELCOME

Deputy Secretary OCDEL Tracey Campanini (Secretary Ortega's designee) welcomed the State Council members and guests to the inaugural meeting.

ITEM 2 – COMMISSIONER WELCOME

Pennsylvania (PA) State Compact Commissioner welcomed members and guests.

ITEM 3 – ROLL CALL

The meeting was called to order at 9:00 AM EST by Commissioner Clemmer and roll call was taken by Commissioner Barbara Clemmer.

ITEM 4 – APPROVAL OF THE AGENDA

Representative Tracy Pennycuick motioned to approve the agenda as presented, seconded by Superintendent Christina Spielbauer. Motion carried.

Members and guests conducted self-introductions. Participants shared their connection to military families.

ITEM 6 – MIC3 101

National Executive Director (ED) of MIC3, Cherise Imai, presented on the compact. Highlights:

- Video message by U.S. Secretary of Education
 - He shared the importance of students feeling connected to the schools.
 - Military families come to the schools as well-rounded individuals because of the experiences they have. Schools need to recognize what these students have to offer.
 - Schools need to step up their support for military families.
 - Dr. Cardona will be sending a letter to State Superintendents/Commissioners to share his support of MIC3.
- Compact 101
 - Overview of what MIC3 is and the purpose of it.
 - Compact supersedes the state legislation
 - Example: A PA school may encounter a student that may not be eligible for Kindergarten or meet the requirement in PA. However, if they move from a state and were enrolled and attended Kindergarten in the sending state, the student must be enrolled in kindergarten and allowed to continue in PA..
 - The purpose is to keep students on grade level, in school, and graduate on time.
- Compact Features video testimonials from Military families
 - Commissioner Clemmer shared she would like to create a similar video showing PA testimonials on Pennsylvania Department of Education's (PDE) website.

ITEM 9 – PENNSYLVANIA MIC3 CASES

Commissioner Clemmer reported on the number of PA cases. In sum, the number continues to increase each year

- o 8 cases in 2018 through 18 cases in 2021
- Currently, we have 9 cases since July
- Commissioner Clemmer shared PA examples.
 - MIC3 ED Imai shared that the national level is willing to help.



- Legal Council
- Mitigation or legal action if needed
- School Choice is the number one question but not covered under compact
- The compact does not allow a family to override charter school rules
- Homeless children is similar; can we combine policies/guidelines?

ITEM 10 – SCHOOL LIAISON OFFICER UPDATE

Ms. Jacqueline Schultz and Mr. Joseph Gordon presented.

- Ms. Schultz stated:
 - Home School pilot program 400 spaces for online courses
 - o Challenges
 - Transfer of credits taken in middle school but considered high school credits in the former school but not in the new school. These credits don't count for graduation requirements in new school, and the students don't have enough credits to graduate.
 - \circ Successes
 - JROTC Carlisle SD supports students going to Cumberland Valley SD for this program.
 - Sports Tryouts and Band
 - videos are allowed to be used for tryouts
 - save spots on teams for incoming military families
 - participate in summer sports and band programs
- Mr. Gordon stated:
 - o Challenges
 - Identifying where the military students are located.
 - Need to continue to spread the word and find ways to educate military families before they move into PA
 - Military OneSource can help with this connection
 - o Best Practices
 - Communicating with Commissioner by sharing the cases coming in.

- MIC3 ED Imai presented.
 - National Guard Active Duty is now covered
 - Temporary residence
 - Excused absences
 - o 2019 Annual Business Meeting Report
 - Dues are \$1.15 per military child
 - o 2020 NGR Survey of States
 - Obtain feedback and insight regarding National Guard Reserves
 - o 2020 Annual Business Meeting Report
 - Support expansion of compact coverage to all members of the Select Reserve to include Traditional, Active/Guard Reserve, and Military Technician (Dual Status) members



- For moves related to changes in duty station and for deployments in active duty
- Concerns expressed regarding the additional dues
- PA is 19th for the number of Active Duty + National Guard and Reserve
- Pennsylvania Dues Projection
- Possible Courses of Action
 - Amend the Compact Statute
 - Amend State Codes Outside the Compact
 - Take No Action at this Time
- State Council must state their position and why, which will be included
 - Guard/Reserve Personnel Movement Over Past 12 months
 - Chart will be shared via email
- State Council will meet in March rather
 - Do we want to include the National Guard Reserve as part of the compact?
 - How can we pay for it?
 - Interstate vs. Intrastate
 - o MIC3 covers interstate not intrastate
 - Develop a 'Welcome Packet' for new families
