The Oregon Legislature passed SB 690 making Oregon's participation in the compact permanent. SB 690 did the following:

- Removed the 12/31/19 sunset on Oregon's adoption of the compact.
- Established the Deputy Superintendent of Public Instruction and State Board of Education members as the membership of the State Council.
- Aligned meeting requirement of State Council to annual meeting national policy.
- Moved staffing of State Council from Military Department to ODE.
