NEW POLICIES ADOPTED

New policies were approved by the Executive Committee on August 20, 2020. Drafted by the Finance Committee upon recommendation of the 2018 Annual Audit, both policies provide guidelines on commission investments and operating reserves.

FY20 END-OF-YEAR REPORTING
