1. Per references (a) through (c), the Navy's designees for liaison positions to provide Department of Defense (DoD) Military Representatives to the State Councils for the Interstate Compact on Educational Opportunity for Military Children are updated in enclosures (1 and 2).
2. Navy appointments as DoD representatives, or Navy supporting are positions driven for all states, and unless otherwise assigned should be the Installation Commander, with their School Liaison as their designated representative and subject matter expert. These DoD and supporting representatives must be O-6 or above and are not able to vote on assigned State Councils as they are assigned ex-officio to the State Council representing the Services.
3. The designees will comply with section 539, paragraph 3-201 of reference (d), and all applicable Federal rules and regulations governing DoD personnel when working as liaisons to non-Federal entities. This memorandum supersedes all other versions.
